


1. Name of the Society:

3. AIMS & OBJECTS:

 - 3.4 To aid or establish, take over or collaborate with any Institution or School or Association for Technical, Professional, Physical, Sports, Mental and spiritual education, enhancement of intelligence and its development.

- 3.5 To adopt Aided /Unaided, Government/Private, School/Educational Institutions of Technical, Professional and General Studies which are being run weak/declared sick due to financial restrain or any other reasons.
- 3.6 To impart the Youths of the Country specially of the Punjab, the Technical, Professional and General Education in accordance with the affiliation to the Govt. and other different Universities, Medical University and Technical University that shall tend to raise the status of Technical, Medical, Professional and General Studies and also Indian Cultural, Professional and General Studies and also Indian Culture and thought and also propagate the teachings of moral and ethical studies.
- 3.7 To organize and sponsor games and sports events/sports activities and also to encourage upcoming and deserving sport persons and players by providing them training, incentive, awards and financial support.
- 3.8 To organize frequent visits and to invite experts/specialists and eminent personalities both from India and abroad from various Technical/Medical/ Professional/ General Faculties for lectures, seminars, conferences, workshops, camps, study groups on subjects of diverse importance related to the fields of Technical, Medical, Professional, General Education, Science & Technology Arts, Indian Culture and any other area of concerned to the Society and in order to achieve the goals of the Society.
- 3.9 To appoint necessary staff required for running the affairs of the Society and for its various Institutions.
- 3.10 To prepare the students of all ages for various Examinations conducted by various Education Boards and / or C.B.S.E/ I.C.S.E,I.S.C.E/I.B and/or NCERT and /or other Educational / Technical/ Medical /Professional/Sports Universities /Boards/AICET under Technical /Professional/ Medical and General Academic Education Development Programmes of States / Central Govt.
- 3.11 To help rise standard of Technical and General Education and to help the brilliant and gifted students financially, especially of the weaker sections of the society.
- 3.12 To organize / undertake and manage the affairs of others likeminded Trusts/Societies/Institutions having the similar Aims and Objects and to receive / give grants for the fulfillment of its one or any of the objects.
- 3.13 To accept donations, raise subscriptions from the members of the Society, its well-wishers, General Public and from other individuals (s), State / Central Government, firm(s)/company(ies), Corporate Sectors or institution (s) from India and Abroad and to invest the funds of the Society with such Bank, Corporations, Public Institutions for providing income to the Society and its Institutions on such terms and conditions as may deem proper and necessary for the betterment and fulfillment of the one or other Aim(s) and Object(s) of the Society.

- 3.14 Chairman Sh. S.K. Punj is hereby authorized to raise loans from any Financial Institutions including Banks against or without securities for the development, welfare and betterment of the Society and its institutions within the Country or Abroad. He is aging authorized to sign all the documents and legal papers and fill affidavit on behalf of the Society for the purpose as desired.
- 3.15 To look after, construct, repair, maintain and mange the building(s) of the Society and its Institutions and other places owned and taken over by the Society.
- 3.16 To sell, purchase, take on lease any part of or full of any land or building to/from any individual/firm/company/institution/society/govt./or Semi Govt. departments on such terms and conditions as may be agreed by both sides under separate agreement.
- 3.17 Generally to take all such steps and measures as might be deemed fit and necessary to carry out the aforesaid or any other Aims and Objects as may be incidental and conducive to the attainment of any one or all of them.
- 3.18 To award prizes in competition of Technical, Professional, Medical, General Education, Sports, Physical Games and Technical/Professional educational competitions and to award scholarships for the needy and to provide ways and means for the upliftment of poor and needy / brilliant students or individuals and to inculcate moral values.
- 3.19 To establish, and maintain new libraries, reading rooms of Technical, Professional, Medical and General Books including Study Centers at one or more places for the use and convenience of students.
- 3.20 To award scholarships, medals, prizes in cash or kind and that like in universities, colleges, schools etc. to encourage the brilliant students achieving distinctions in the fields of Technical, Professional, Medical, General Education, Sports, Passing Civil Services and other Armed Forces competitions and for higher and better education.
- 3.21 To give stipends, allowance or gratuities recurring or otherwise, to the staff of the Institutions of the Society for its maintenance etc. for such time or duration as may deem fit and necessary.
- 3.22 To do any other act or job which is ancillary to the achievement of any of the above stated objects.

4. All the incomes, earnings, movable and immovable properties of the Society whatsoever derived shall be solely utilized and applied towards the promotion of the Aims and Objectives only as set forth in the Memorandum of Association and no portion thereof shall be transferred directly or indirectly by way of dividends, bonus, profit or in any manner whatsoever to the members of the Society or to any person claiming through any or more of the members. No member of the Society or its Institutions shall have any personal claim on any movable or immovable properties of the Society or its institutions or make any profit, whatsoever by virtue of his/her membership. As such it leads to philanthropic works.
